4. Discussion points from attached reports

a) Table of contents for Board Binder

b. OGN (Office of Great Neighbourhoods) workshop date

- Bellevue is on the City's schedule for neighbourhood revitalization in 2018. Bellevue is on a pilot for a new City consultation process.
- The City is requesting a one-hour meeting with the board (from 7-8 p.m.) at the September board meeting to review the neighbourhood revitalization plan.
- Feedback to CRC from meeting with City on Tuesday, June 28:
 - As a participant in the pilot, we're not sure what's being asked of us as a community.
 - There should be more of a combined effort (City and community) to determine what is being revitalized.

- Additional comments shared were noted by Kelly (CRC) to bring back to those at the City leading the process.

a. Facilities Report (Brian Finley)

- New alarm system is in place, codes have been issued.

- Re-key of the hall is underway.
- Edmonton Tool Library has received a draft contract, waiting for their response.
- Minus One club has requested dates for 2017, board members asked to review and identify any conflicts or concerns with the dates as outlined on the calendar.
- In support of the First Nations powwow during K Days and the increased need for parking to allow the program to occur, we are allowing Northlands to rent the parking lot and hall. The parking lot will not be accessible for the duration of K Days.

Results of audit / Northlands Vision 20/20 (Brian Finley)

- In order to run a casino, the League needs two full years of audited and approved financial records
- We now have audited financial statements from the beginning of 2014 to end of 2015
- Ed to make a Doodle poll to board members to see if August 23 (first choice) or August 16 (second choice) will work as a date for a special general meeting.
- Since the audits weren't presented at an AGM, a special general meeting needs to be called. Community League Members must be notified of the special general meeting 21 days prior.
- Brian proposed that communications to members about the special general meeting will let members know we are reviewing and approving the audits as well as seeking input about Bellevue's position on Northlands' Vision 2020

 approving Brian Finley to speak in support of Northlands Vision 2020 on behalf of the Bellevue Community League on or about August 31st to Edmonton City Council.
