 - a. Anna Vesala (NRC)
 - Feb 2 & 16 is the "Hypothermic Half-marathon"
 - Thursday is the Exhibition Lands planning framework session; drop-in style
 - A number of directors noticed that the Bellevue CL hall was missing from the renderings and will be raising this concern at the session
 - Drop-in curling for newbies at the Thistle on Tuesdays
 - EPSB public info session on budget Jan 30 6:30-8pm at Highlands School
 - Seniors service public engagement next week (3 sessions)
 - Grant opportunities: Anna distributed a table of commonly-accessed grant opportunities
 - Rick asked if Anna had any information on repurposing of the jockey quarters for transitional housing
 - To Anna's knowledge, this is still being considered for rezoning
 - b. Edmonton Toy Library (Kyla Fisher)
 - Toy Library update
 - Kyla has met with a number of people who are interested in the Toy Library
 - Facebook and Instagram presence has been established
 - Kyla will be setting up a Google Form to collect volunteer information
 - Goal is to hold toy drives every Sunday in February

- Will be communicating through a number of social channels (e.g. Highlands Baby Facebook group)
- Considering hosting an open "play day" in the hall featuring various activities and library toys
- Rick asked if BCL should consider offering the babysitting course and/or a babysitter registry
- After the toy drives in February, the Toy Library will assess their donations and hopefully launch in March, opening on one weeknight and one weekend day per week
- Kyla will bring a six-month plan to the next meeting
- Sherry asked how storage would be arranged
- Kyla responded that there is a large shelf that will be placed in the coat room and stocked in large Rubbermaid-style containers
- Bright Horizons is interested in contributing, and hoping for some acknowledgement where possible
- Kyla has been discussing with Boom Bags Edmonton re. Toy Library reusable bags
- Kyla presented an itemized request for \$500, including cleaning/storage materials, logo, and estimated contingency
- M/S/C Tim/Sherry that the Edmonton Toy Library be given \$500 to support the presented request
- c. Edmonton Tool Library
 - Spring door campaign deadline for submitting a small pamphlet for inclusion?
 - Rick noted that this deadline has not yet, but that we will keep the Tool Library informed
 - The Tool Library has had a number of discussions around the broader sharing economy
 - Lots of opportunities for collaboration with the Toy Library and others
 - Kyla mentioned that the league may wish to investigate holding "swap" events
- d. Community Safety Director (Nazio Filice)
 - i. History of Bellevue Community League being involved in any Neighbourhood Watch programs
 - Nazio attended the recent Edmonton Neighbourhood Watch presentation
 - BCL has participated in the past, but not in any recent years, simply due to lack of volunteer capacity
 - ENW encourages residents to report any suspicious behaviour and to promote safety
 - ii. Interest in potential programs if Bellevue Community League joins Edmonton Neighbourhood Watch
 - Programs include "Walk Your Block" -- not an active patrol, but an effort to have ad-hoc walks in the neighbourhood
 - ENW also has a sign program, providing signs to post at community entrances or other strategic locations
 - Nazio would be willing to act as BCL's Neighbourhood Watch representative, if the board is interested
 - iii. Potential motions:
 - M/S/C Nazio/Tim that Bellevue Community League join the Edmonton Neighbourhood Watch Program and establish an official program for the Community League through Edmonton Neighbourhood Watch
 - M/S/C Sherry/Ed that BCL appoint Nazio Filice as Bellevue Community rep for the Edmonton Neighbourhood Watch Program
 - Depending on what potential programs are of interest/value to the league, there may be a
 potential motion to approve particular programs to implement through Edmonton
 Neighbourhood Watch
